



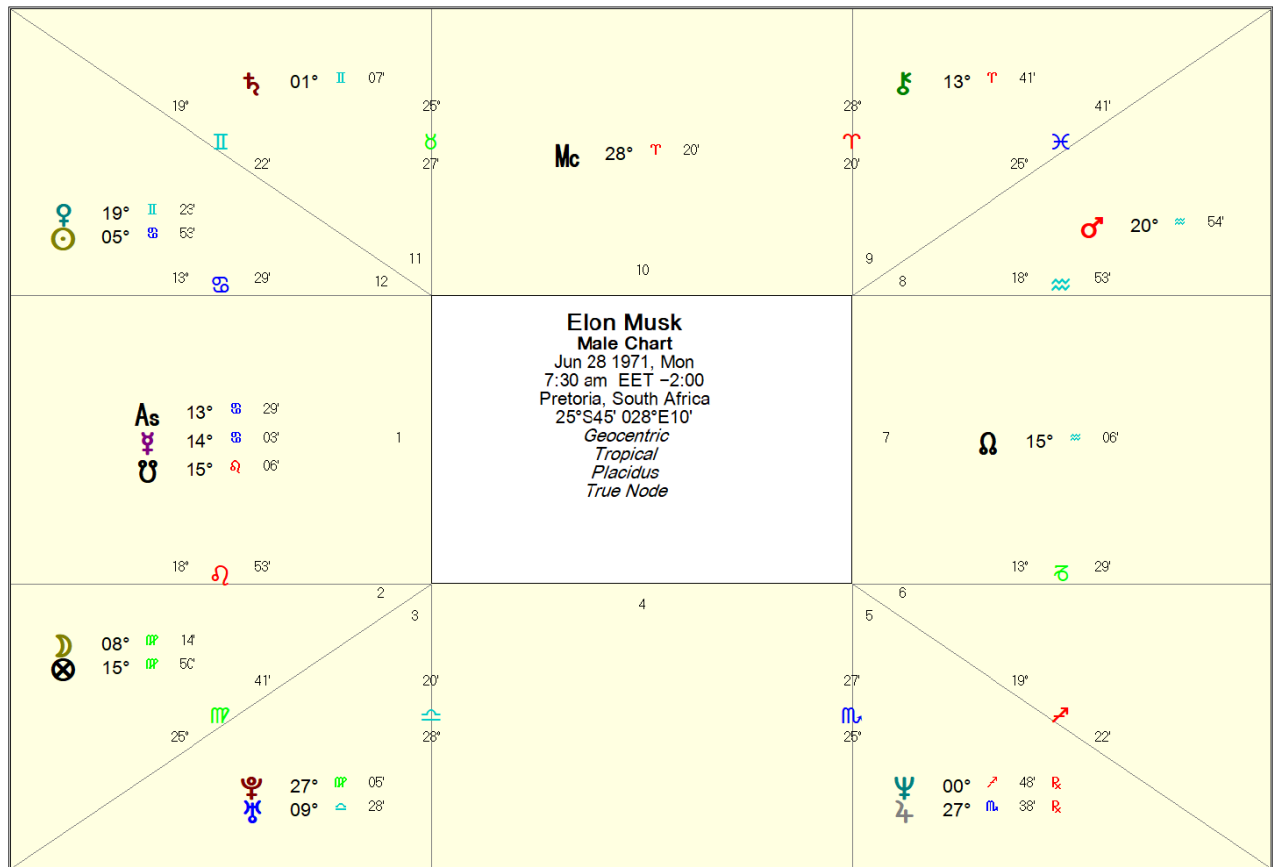

EXEGESIS

Investing versus Speculating

It is critical that the subject of this report understand that there is a fundamental difference between investing and speculating, the former distinguished by lower risk in exchange for more modest gains, the latter by higher risk in exchange for potentially higher returns. In brief, in astrology, investing, saving and protecting one's assets fall together under one category, and speculation falls under a separate category. However, unless the first category is strong or at least stable, that is, the category of investing, saving and protecting one's assets, the second category, that is, speculation, cannot be considered strong. In other words, while the periodic strength or weakness of the first category is measured independent of the second, the strength of the second category is first measured by the strength of the first category, and then by its own merit.

Overlapping Influences

At times two or more astrological influences will be in effect at the same time and on occasion these overlapping influences will contradict one another. In the process of interpretation the stronger influence will normally be the only one that is mentioned in the report due to its tilting the scale of Fortune and Misfortune to one side or the other. Still, at other times, some overlapping influences will be deemed of equal strength, and thus both will be reported. While this may cause some confusion, it is considered to be an indication that while a loss may occur in some specific area of the subject's affairs, a gain can also occur, simultaneously, in another area.

Force Majeure

As it relates to this report, *force majeure*, along with earthquakes, tsunamis, train wrecks and war, etc., can also indicate losses to a specific asset due to its dropping in value in sympathy with a decline in the broad market or in response to a major economic event.
