

The U. S. Zodiac Forecast for the 2024 U. S. Presidential Election

For the purpose of world or national event analyses or forecasts astrologers who employ the classical or medieval methods will first make use of the *Annual Revolution* – a geocentric chart cast for the precise moment the Sun, in its annual path (a *revolution* around the Earth), enters the sign Aries, and for the purpose of establishing the all-important Ascending degree (the zodiacal degree rising on the Eastern horizon at the precise moment the Sun enters the sign Aries), the astrologer will cast the chart for the longitude and latitude for the capital of the nation or the central-most point of the region to be examined. The underlying theory for this is that the Annual Revolution will give the astrologer a snapshot, so to speak, of the major (and sometimes, many minor) events to occur in that nation or region during the solar year ahead (as measured by one entrance into the sign Aries by the Sun to another).

U. S. Zodiac employs a variety of astrological techniques that include some ancient methods, a full use of the medieval techniques, as well as some modern and a number of proprietary techniques, so while there is a lot more going into our work than the Annual Revolution alone, it [the Revolution] remains central to all things in terms of the analysis and forecast of the year ahead, and specifically for determining what the stars incline in regards to a presidential election. But there are, however, other astrological events that will have a great bearing on not only world and national <u>events</u>, but also upon the prevailing <u>psychological inclinations</u> of, and general <u>perceptions</u> held by, the masses. Examples of these astrological events include eclipses and what is referred to as *great conjunctions* – the periodic events wherein the slower moving planets occupy the same degree of the zodiac at the same time. Anciently, the *Great Conjunction* referenced the planets Jupiter and Saturn, because they were the only planets known at that time to conjoin past faster moving Mars, the slowness of the event inferring an ominous impact

upon society, and with this conjunction establishing an approximate 20-year economic cycle. Modernly, we are aware of great conjunctions involving Uranus, Neptune and Pluto, as well as any of those planets combined with either Jupiter or Saturn. By including the great conjunctions formed by these additional stellar bodies and then placing them all on the timeline of history, we find their presence uncannily near or at the time of great shifts in the direction mankind moves towards, or the conditions under which mankind lives. Some of these great conjunctions, and their progression from one sign to another, as well as the conjunctions' progression through the degrees of that sign (as the case may be), can cover very large spans of time – such as thousands of years. Finding conditions recurrent under specific great conjunctions separated by such long periods of time can be tricky, and in some cases, impossible. But for those great conjunctions for which a general influence can be clearly identified, we can then look forward to the next, or the next after, and hypothesize an underlying trend for the time in question. The sign occupied by the conjunction of the planets, as well as the degrees of the sign in which the conjunction occurs, will have a great bearing on the amount of impact and the form of the impact, the stellar event has upon society. Additionally, subsequent angular relationships to and from the conjoined planets, as well as other planets forming significant aspectual relationships or placed in key zodiacal degrees at the time of the great conjunction, will also have a significant bearing as far as how the overall influence plays out during both its period of activation, as well as the lingering consequences (good or bad) of the primary events or changes the great conjunction set into motion, or with which it coincided.

Case in point, the February 8, 1845 conjunction of Jupiter and Uranus, and the zodiacal degree in which the conjunction occurred in, signified world-changing events in the form of radicalized views on economic matters. This Jupiter-Uranus conjunction reached exactitude at a time when the Sun conjoined Neptune in the sign of Aquarius, the latter event producing an influence now known to be highly socialistic/communistic in nature, and thus influenced the outcome of the Jupiter-Uranus event. In 1847 Karl Marx wrote his Communist Manifesto, and in 1848 it was published in London, England – a parts one and two event well within the influence of the great conjunction, and with staggering consequences persisting to this very day.

Another case in point, the 1927 and 1928 conjunctions of Jupiter and Uranus (due to retrograde motion they conjoined three times) and the zodiacal degrees in which the conjunctions occurred in, again signified world-changing events in the form of radicalized views on economic matters. This protracted and ominous stellar event preceded both a peak in speculative madness in the American stock market, and within five years (a short span of time in terms of great conjunctions) the electing of a Fabian Socialist (Franklin Delano Roosevelt) to the US Presidency. New Deal or raw deal, the effects of FDR's radicalized policies on economic distribution persist now nearly 100 years later, demonstrating that while the Annual Revolution will give the astrologer a snapshot of the year ahead, it is also necessary for the astrologer to understand what long term influences the world is under due to the various great conjunctions.

The recent Jupiter-Uranus conjunction of April 20, 2024 in the sign Taurus allows for at least the *opportunity* to temporarily reverse the losses brought about by the destructive effects of the radicalized economic policies of past. On the downside, and specifically for the USA, it is also an indicator of the potential for massive amounts of financial and material resources to be allocated to warfare during the time of March 20, 2024 through March 19, 2025, (The 2024 figure demonstrates the allocation of these resources to the purpose of warfare as being done in opposition to the will of the majority of the people.)

Full explanation of the following statement will not be given until a planned subsequent report is completed, thus we apologize for the teaser, but for now we will state that, along with the lingering effects of the aforementioned Jupiter-Uranus conjunctions, and due to the influence of a series of very destructive stellar events that occurred starting in the mid-nineteenth century and not only persisting through, but peaking at, the latenineteenth century (and effecting the whole world and not just the USA), the otherwise beautiful world that should be present within the borders of America has undergone great challenge, and inarguably, has even been cosmically undermined. To clarify, it is U. S. Zodiac's position that humanity as a whole is not moving in the right direction, that is, if one defines the right direction as ever-increasing civility and the gaining of greater philosophical understanding. As a matter of fact, it would appear as though the door leading to that lofty state of being was abruptly slammed shut by the Cosmos just shortly after the signing of the American Emancipation Proclamation. The timing of this event would suggest that it was near the time of the signing of this document that, combined with American independence and the implementation of the US Constitution, mankind had just in that moment (for a hundred years or so is but a moment, astrologically) achieved its pinnacle state of being – its highest point of civility and philosophical understanding, and from that point forward, mankind would begin the process of undoing itself in a slow, painful and disgraceful manner, until once again it finds itself in the proverbial gutter (and on its way into the sewer). This slide into the gutter (or sewer) will continue until late into the twenty fourth century, at which time the stars will reverse the influence, and thus finally being permitted to do so, mankind (or whatever is left of it) will most likely be compelled by such horrific conditions so as to come to its collective senses and once again lift itself up.

Now understanding that astrologically speaking, since slightly past the middle of the nineteenth century, the state of humanity has not been getting better when viewed in the big picture (nor will there be anything but temporary improvements at present or in the near future), we will make use of the Annual Revolutions to look into the US election cycles of the past for the purpose of gaining insight into the future. (Note that as it is unrealistic to attempt to cover every US election in a report intended to be relatively brief, only a few critical examples will be given.) Remembering that the Annual Revolution takes place most often on the twentieth day of March of every year, the quadrennial US presidential elections are held during the first week of November, and inauguration of a succeeding president occurs the following year, the Revolution is an indicator of the winner

of the election and that winner's character, connections (family, social and business), and the election winner's intentions as he or she held them at the time of the winning of the presidential election. In this part of the report we will offer our interpretation of the Annual Revolution for various election years as it relates to the election of a new office holder for the presidency, and allow the reader to draw his or her own conclusions.

The Annual Revolution of 1912 and 1916:

In this figure of the stars, the warning given is that of a *great deceiver* ultimately winning the office of the president later in the year, and a voting public easily swayed by his lies. This deceiver will have connections to morally corrupt men and represent the interests of financiers over the interests of the American public. The Annual Revolution of 1916 portends the return of an incumbent president engaged in egregious abuses of power and with direct alliances to domestic and foreign war-profiteers.

The Annual Revolution of 1932, 1936, and 1940:

The 1932 Revolution suggests that the vote – the will of the People – will be cast from a position of economic desperation. The stars further warn that the individual to ultimately win the presidency will be focused almost entirely upon money and the distribution of the nation's public and privately held assets and resources. The Annual Revolution of 1936 warns of the decay of America's core values due to the winner of the presidential election's radical socialist ideology and his intent to redistribute the nation's resources. The Annual Revolution of 1940 warns of the election winner's intent to engage in skulduggery in matters of foreign relations, as well as an intention to engage in war-profiteering. This same chart indicates the voting public's being motivated almost entirely by greed.

The Annual Revolution of 1944 and 1948:

In the 1944 figure of the stars, the warning is of two Presidents during the quadrennial period beginning in the 1944 solar year (Aries on the Medium Coeli with Mars in the sign Gemini) with both holding intentions to act against the best interests of the nation and its people, and instead, working in the interests of foreign and domestic financiers through the misuse of foreign policy. The 1944 figure also suggests both winners of the election as being sufficiently ruthless so as to be willing to engage in nearly any violation of international law or abuse of human rights in foreign lands in order to achieve their objectives. The stars depict the voting public as mostly unaware of their candidates' wickedness during this 1944 election year. The figure of 1948 warns of essentially the same things in regards to the election winner, and depicts the voting public as ambivalent towards the election winner's questionable integrity and intentions towards violence.

The Annual Revolution of 1960:

The figure for 1960 foretells of the voting public's near perfect split in its support for two candidates, as well as the public's state of confusion on the matter and vacillation from one candidate to the other. More foreboding, the 1960 Revolution warns of a man of good intentions towards the American people as winning the presidency later in the year but

with a secret enemy in close proximity to him – a secret enemy next in line to him for the office of the presidency – a secret enemy intent on working against the USA and its people – a secret enemy with connections to powerful people in the intelligence community – a secret enemy who is also prone towards audacious and violent acts.

The Annual Revolution of 1964:

The figure for 1964 indicates this year as one during which Fate deals a wicked blow to the USA through a wicked man's winning the presidency later in the year. The 1964 Revolution foretells of an election that is won via the public's being both defrauded and deceived, as well manipulated by the press. The 1964 figure forewarns of an election winner whose intentions are towards undermining America's national security by purposefully exposing the USA's secrets to foreign nations, and an intention to misuse America's armed services for the purpose of war-profiteering.

The Annual Revolution of 1976:

The figure for 1976 indicates the presidency being won by a shockingly ineffectual man representing the interests of American plutocrats – a puppet. The stars also suggest this election winner's presidency as *a flash in the pan*.

The Annual Revolution of 1980:

The figure for 1980 indicates a man of good character winning the presidency later in the year and his holding the intentions of truly representing the best interests of the working and middle classes. The 1980 figure also indicates the election winner as having an embittered (secret) enemy second in line to him for the office of president and holding the intention to undermine the election winner's efforts and to even injure him. The stars also suggest the winner of the election as entering into the presidency against the will of a secret and treasonous cabal comprised of political operatives, financiers and industrialists.

The Annual Revolution of 1984:

The figure of 1984 indicates a man of great integrity winning the office of the presidency but under the conditions of his being surrounded by treacherous men of low moral character engaged in corruption, violations of domestic and international law, and treason.

The Annual Revolution of 1988:

The 1988 figure indicates a man of low moral character winning the office of the presidency later in that year and his having a single focus in mind: accessing America's public purse and appropriating the nation's resources. The figure also indicates this victor in the election as having multiple ties to men who are also of very poor moral character.

The Annual Revolution of 1992 and 1996:

The Annual Revolution of 1992 indicates a man disloyal to the USA and of extremely poor moral character winning the office of the presidency and doing so under damning astrological influences upon America. Within the figure of 1992 is the activation of the

degree of the zodiac representing the covert presence and activities of the Chinese Communist Party in US affairs. The Annual Revolution of 1996 again indicates a man of despicably low character ultimately winning the office of the presidency later in the year, with the voting public beguiled by the man's charisma, and taken in by his many lies. His holding the intent to misuse America's military resources on behalf of American and foreign plutocrats is highlighted.

The Annual Revolution of 2000 and 2004:

The figure cast for the year 2000 indicates that the voting public is particularly subject to falling for the candidate with the most charisma; in this case, the stars indicate the winner of the election later in the year as a wealthy and charismatic thug disloyal to the USA, with the sole focus of accessing the nation's treasury and pilfering all that could be pilfered from the public coffers. The stars indicate the winner of the year 2000 election as being treacherous, deceptive, an outright liar and sufficiently ruthless to violate any law in the process of his obtaining his objectives. The figure cast for year 2004 indicates that the voting public will be fooled yet again, and the winner of the election that year being a disloyal, lawless thug holding the intentions of pilfering the nation at any cost.

The Annual Revolution of 2008 and 2012:

The Annual Revolution of 2008 foretells of the transition of power later in the year from one self-serving, duplicitous political insider to another. The 2008 figure indicates a voting public strongly desirous of a change in political party. The intentions held by the election winner of 2008 is to pacify the masses through small (token) handouts, while pilfering the public coffers. Within the figure of 2012 is a warning of undue influence by plutocrats upon the year's election winner, and the activation of a specific zodiacal degree associated with the Chinese Communist Party's presence in America's affairs. The 2012 figure indicates intentions on the part of the election winner that are almost entirely focused upon accessing the public purse and establishing radical economic policies.

The Annual Revolution of 2016:

In the figure of 2016 the stars make clear that the public's vote is motivated by a desire for a change in political party and a strong inclination towards recapturing America's traditional values. Infrequent in these Revolutions, the figure for 2016 clearly indicates an election winner with an honest intention towards representing the will of the People and revitalizing the working and middle classes, as well as an equal intention to oppose plutocratic forces covertly working against America from within the nation. The 2016 figure makes clear that the intentions of the press (collectively) is to slander and intentionally mischaracterize the eventual election winner.

The Annual Revolution of 2020:

The figure of 2020 demonstrates a benefic presidential incumbent in a greatly weakened state, and the winner of the election later in the year as a disloyal and morally corrupt man holding intentions towards pilfering the public purse and engaging in war-

profiteering. The 2020 figure indicates the voting public as being defrauded, deceived and manipulated. Equally, the 2020 figure indicates the winner of the election as being connected to both American and foreign financiers, as well as to the degree of the zodiac that has proven again and again to represent the covert presence and interference of the Chinese Communist Party in American affairs.

For those who possess both the ability to read an Annual Revolution and the unemotional objectivity to properly delineate the chart (as well as some knowledge of American history and an understanding of how the world truly runs and who truly runs the world), it is crystal clear that the Annual Revolution does in fact give full insight to the prevailing general trend followed by Americans as they cast their votes in the election process. It is also equally clear that the Annual Revolution reveals a great deal about the voting process, including voter manipulation or interference, the activities of the press in the voting process, the presence of significant fraud as the vote is counted, as well as foreign interference or influence, and add to that, revelations regarding the character of the candidates and the incumbents, shifts in power, and what the nation can expect to gain or lose under one president or another. Conversely, those who cannot read an Annual Revolution are dependent upon the astrologer of their choice for the information. For instances such as this the British have a most useful maxim wherein it is written, "The proof of the pudding is in the eating."

THE FORECAST

The Annual Revolution of 2024:

The figure of 2024 indicates an incumbent president in poor health, weak willed and subject to exploitation, but who is also willing to engage in the most shameful, corrupt and despicable acts. The figure of 2024 also indicates the presence of a contender for the office of the presidency from the party already in power. The figure of 2024 indicates the challenger from the party opposing the party in power as a male with a forceful and fearless personality, as well as his being calumniated by the press. In terms of planetary aspects, the figure of 2024 shows no clear path to the presidency for the challenger from within the party presently in power. Conversely, as measured by planetary aspects, the figure of 2024 indicates a difficult path to the presidency for the challenger from the party opposing the party currently in power, but a path nonetheless. Lastly, in the analysis of the will of the People in this matter of a presidential election, the figure of 2024 indicates a vote that will be subject to some small measure of fraud, but a majority base of voters motivated by anger and overwhelmingly receptive to the challenger from the party opposing the party currently in power. The Annual Revolution of 2024 indicates the winner of the 2024 presidential election as holding the intentions (at the time of the election) to negotiate for peace and to bring stability to matters of foreign relations, the intention to strengthen the US economy as well as the intention to replenish the public coffers. Moreover, the 2024 figure suggests that the election winner also holds the

intention (at the time of the election) to reestablish the rule of law and to ensure the protection of the USA's citizens.

Preliminary judgment:

Considering the nature of the event in question, the identities of the individuals represented within the Annual Revolution are crystal clear, and thus, we judge the Annual Revolution of 2024 as foretelling a presidential election victory by Donald Trump over Kamala Harris.

Adjuvant:

As stated in page one of this report, U. S. Zodiac employs a variety of astrological techniques in the analysis of most matters, and this momentous event received no less than the full treatment. For our final judgment of this matter, we have analyzed the horoscopes of Donald Trump and Kamala Harris, as well as the horoscope of J. D. Vance and the solar chart of Tim Walz. We have analyzed the horoscope of the USA, both on its own merits, as well as in relation to the four contenders, and the chart of the event itself, Election Day, November 5, 2024. Our analyses complete, we have applied the data to a weighted index by which to judge the relative strength of each individual candidate's potential for victory, with a score of 1 being the weakest potential for victory, and a score of 10 being the strongest potential for victory.

Final judgment:

Making use of the multifarious charts we have cast for each candidate, the USA and the Election itself, we have used the rendered data with our weighted index and calculated a relative strength number for Donald Trump of 9 - 9.5. For Kamala Harris, we have performed the same analysis, and calculated a relative strength number of 6.5 - 7. For J. D. Vance we have calculated a relative strength number of 8.5 - 9. And for Tim Walz we have calculated a relative strength number of 7 - 7.5. The combined influences of the Trump-Vance ticket produces a relative strength number of 8.75 - 9.25. The combined influences of the Harris-Walz ticket produces a relative strength number of 6.75 - 7.25.

By what is revealed within the Annual Revolution of 2024, the ominous great conjunctions of years past, and combined with the adjuvant analyses and relative strength numbers produced by the weighted index, U. S. Zodiac's final judgment on, and forecast for, Election Day, November 5, 2024 is a Trump-Vance victory.
